1.1 Materials

1.1.1 Prefer maximum 24”x24” modular carpet tile with structured back.

1.1.2 Dark colors preferred.

1.1.3 Use only carpet that meets or exceeds Green Label Plus, set by the Carpet and Rug Institute.

1.1.4 Preferred construction:

1.1.4.1 Textured/level loop

1.1.4.2 Patterned/graphic loop

1.1.4.3 Multi-level/textured pattern loop

1.1.5 Prohibited construction:

1.1.5.1 Broadloom

1.1.5.2 Cut pile

1.1.5.3 Peel and Stick applied carpeting

1.1.6 Prohibited fiber: Olefin

1.1.7 Manufacturer requirements:

1.1.7.1 Must have a minimum of ten (10) years in the production of modular carpet tile products as a “running line” part of product offerings.

1.1.7.2 Specific carpet tile backing system(s) must have a manufacturer’s history of at least five (5) years.

1.1.7.3 Minimum fifteen (15) year manufacturer’s warranty covering: wear, edge ravel, tuft bind, delamination, and static control.

1.2. Off-gassing must be complete prior to Operational Occupancy.
